A polygraph test - The FBI (Federal Bureau of Investigation) uses them upon employment application, and I have called for the test to be used regarding the Police VS Kurt Slaven statement for a decade now. SAPOL refuses resolution in any form, especially a lie detector test that I would pass as honest, and their paedophile would fail, proving his guilt.

It starts at Margaret Street in Mount Gambier, South Australia - after the SAPOL officer, a Mount Gambier district Criminal Investigation Branch (CIB) detective investigating the theft of my structurally written off VH Holden Commodore, sexually assaulted myself at a pine's location in approximately March of 2001. It ends exposing decades of police and governance corruption defined by a cover up of sex industry engagement including the use of children as sex workers by police forces of Australia, the public disclosure of an elusive looming spread of STD's, vile criminal negligence by police and government, and even a Freemason agenda to Gaslight the world and rewrite history like Nazis at times. All this criminal corruption is to cover up sexual criminality amongst the elites of society.

A book full of so many facts, the government and police heavily disrupted my manuscripts and tried to stop its printing. This book was revised numerous times to ensure accuracy, truth, and relevant details for a just resolution under the Public Information Disclosure (PID) Act. The book was registered as a publication with the National Library of Australia (NLA) in 2019, and the ambiguous manuscript was released to the Australian Associated Press (AAP), journalists across Australia, yet the cover-up continued for over half a decade. More than one print contract has been signed for this publication, the initial print a self-publication in Queensland, which was refunded (not entirely) due to, I quote, 'the government' not allowing print stated In-House Publishing self-publishers.

Former friends and family cast aspersions on my character. Damaging remarks and judgments coming about out of perception-based and fact-less aspersions stemming from police, failed operations, false investigations, and all those low enough to seek benefit. Aspersions; always damaging, always defamatory. A character assassination, pursuing allegations, frivolously and cowardly sourced - supposed anonymous sources making aspersions completely untethered from reality. A character assassination of shoot first, without any evidence, and with no care for the people (or legal ramifications) harmed in the process. No one cared enough about engaging with defamation that was an attempt to damage my character to seed a platform to obstruct justice for myself and Australia's most vulnerable demographics - the disabled, and children.

Exposing the Elite STARForce team of the South Australian Police Force as an organised crime gang engaging in crimes as severe as crimes against humanity. Australian Federal Police in 2023 proved irrefutably to have been involved in actions of assisted suicide, trying to push persons, including myself, over the years (decades) to try and seek the refuge of suicide. Illegal activity comprising of offences listed under the Torture Act targeting whistleblowers, return service personnel, prostitutes, etc.

“You lose your Integrity when you are worse than the people you are chasing.” stated an Australian Human resource - expert interviewed for Australian ABC 4 Corners aired via free-to-view TV in 2023. Turning a Police Force into Criminals was as simple as implementing legislation violating human rights and constitutional rights. Atrocities and offences committed against any civilian population, as part of a widespread attack, including:

Murder, extermination, enslavement, deportation, mass systematic rape and sexual enslavement in a time of war and other inhumane acts.

Not to mention, under section 12 of the act, it is an offence to conspire or agree to murder a person or to solicit, encourage, persuade, or try to persuade a person to murder another person. This is also punishable by a maximum of life imprisonment. In South Australia, conspiracy to commit murder is outlined in section 12 of the Criminal Law Consolidation Act 1935.

**The South Australia Police** - commonly known as **SAPOL**, is the police force of the **Australian state of South Australia**. It is an agency of the **Government of South Australia** within the **South Australian Department of Justice**. **ICAC SA - The Independent Commission Against Corruption (ICAC)** is a **South Australian integrity agency** associated with the **South Australian Office of Public Integrity**. ICAC (SA) was established by the

Labor Government of South Australia in 2013 under the Independent Commissioner Against Corruption Act 2012. **The Australian Federal Police is the national and principal federal law enforcement agency of the Australian Government, with the unique role of investigating crime and protecting the national security of the Commonwealth of Australia.**

Every police force in Australia is rotten to the core. The price of unlawful enforcement was not only my life as I knew it, but the National Security of Australia, the governance of our people, Integrity, International Intelligence, and So Much more.

**Criminal Negligence is rife in government. This book outlines SAPOL criminal negligence, which recklessly endangered my life, as well as other examples of severe negligence in governance.**

**The chain of causation is the events that make up causes and effects. The chain of causation is the links that bind cause and effect together. An action causes an effect; the chain is the unbroken link between action and effect. Think of every negligence case as a chain.**

Criminal Negligence: flouting accountability involves First and foremost the denial of fact...

(1) The first denial is the "denial of fact". This is the person's refusal to acknowledge that an inappropriate act even occurred. He or she is likely to say such things as "it never happened, you're wrong, your allegation is not true." So the first level of acceptance is for the person to acknowledge that the problem is a real one.

(2) The second denial is "denial of impact". This is the attempt by the person you confront to minimize the importance of the event you are bringing to their attention. At this stage a person is likely to make statements such as "it's no big deal", "don't be so sensitive", "you're making a mountain out of a molehill." These are all examples of how a person may downplay the importance of the problem he or she caused. The second level of acceptance is for the person to admit that the problem or infraction not only exists but that it is serious.

(3) The third denial is "denial of accountability". This is an attempt to avoid responsibility for a misdeed through some sort of explanation that the circumstance was somehow out of the person's control. "I was stressed out", "I had too much to drink", "I was in a bad mood" are all examples of attempts to deny responsibility for the problem. Sometimes the person will even try to say you brought the damage on yourself, i.e. "You made me hit you". The third level of acceptance is for the person to assume full responsibility for the inappropriate action.

(4) The last type of denial is what I call "denial of hope." It takes the form of refusing to acknowledge the willingness to do the work to improve the situation. "That was in the past so there's no point in bringing it up", "that's just the way I am", "nobody's perfect" are all examples of how a person can try to duck responsibility for making things better. The fourth level of acceptance is for the person to actively demonstrate remorse and a desire to heal through words and actions.

To summarize, denial of fact says that the offense in question never happened, denial of impact trivializes the consequences of the inappropriate behavior, denial of responsibility attempts to justify or excuse the behavior, and denial of hope shows that the person is unwilling to take active steps to make things better.

Put this all together and you are likely to hear some version of the following four denials from a person you confront: "It didn't happen like that, it's no big deal anyway, it wasn't even my fault and besides there's nothing that can be done about it."

The Four Denials Of Responsibility

Denial (aka Perjury) is what Australian Police Forces used for years to cover the most heinous of crimes. Obstructing justice – AUS Law; Section 319, provides a general offence of perverting the course of justice by doing any act or making any omission in order to pervert the course of justice. This is punishable by a maximum of fourteen years' imprisonment.

The SAPOL police predatorial monster in 2001, *Kurt Gavan Slaven* (DOB 07NOV1958; SAPOL/ADF - Navy), assigned to investigate my white five-speed manual, four-cylinder VH Holden Commodore, spent decades denying and hiding his crimes against young women in Mount Gambier and surrounding areas.

The Commodore was stolen after an accident near my Aquatics Teaching employment premises. A sixteen-year-old Aquatics Teacher, government employed with police clearance, was raped under duress by a SAPOL Police Officer and a Detective of Mount Gambier Police Station CIB (Crime Investigation Branch). The officer was a predator who had no Real intentions of investigating the theft case of my vehicle, which was involved in an accident the day before the sex crime offence. My economically written-off vehicle, stolen overnight from my employer's private car parking, was the event that enabled *Kurt Gavan Slaven* (DOB 07NOV1958; SAPOL/ADF - Navy) to commit the sex crime. The theft of the vehicle was linked to individuals known to Kurt Gavan Slaven (DOB 07 Nov 1958; SAPOL/ADF - Navy), a gang of boys, and the COA, which consisted of *persons unknown to me between 2001 and 2009*. Luke Hubert Scheidl (DOB1981 Mount Gambier District, South AUS), Chad Rick Modra (DOB1981) – Modra brothers, Carl Andrew Brodie (DOB08FEB1984), Sean Irvine (DOB18AUG1981), Ricky Noonan (Mount Gambier District, South AUS 2013) amongst names associated with these police assisted felons. Some of these names are associated with a homicide case that occurred in 2013 in the states of South Australia and Victoria. One of these names ended up in witness protection, to which he communicated to family and friends; furthermore, he was never under threat during this period. A misappropriation of taxpayer funds occurred due to their involvement in police corruption, linked to *Kurt Gavan Slaven* (DOB 07NOV1958; SAPOL/ADF - Navy).

Authoring this Autobiography, after the homicide in 2013, it was evident that Kurt Gavan Slaven (DOB 07NOV1958; SAPOL/ADF - Navy) targeted me to commit this offence. *Kurt Gavan Slaven* (DOB 07NOV1958; SAPOL/ADF - Navy) committed his hideous sexual crime and orchestrated a cover-up within a venal police force, leading to further sexual offending against me for years. Corruption and deceit that span decades, recklessly endangering my life.

SAPOL, a police force who used my person as quote “rape bait” numerous times over the years after *Kurt Gavan Slaven* (DOB 07NOV1958; SAPOL/ADF - Navy) criminal offence. An irrefutable fact announced during a federally overseen homicide investigation by the state police department's human resources (aka informants). A seedy, procedure-embedded, rape culture exposed. SAPOL, predominantly STAR (Special Tactical and Response) Force, further compromised my life for years with a police certification which was initiated for me and cancelled for myself, being visible and visibly removed from government records recorded for many, many years.

Rape has been used as a weapon of war and oppression throughout history. It has been used to degrade women and their communities, for ethnic cleansing and genocide. Rape culture is pervasive. It's embedded in the way we think, speak, and move in the world. While the contexts may differ, rape culture is always rooted in patriarchal beliefs, power, and control. “Boys will be boys.”; “She was drunk.”; “Women say “no” when they mean “yes.”

Rape culture is the social environment that allows sexual violence to be normalized and justified, fuelled by the persistent gender inequalities and attitudes about gender and sexuality. Naming it is the first step to dismantling rape culture. Rape culture is held up by the absence or lack of enforcement of laws addressing violence against women and discriminatory laws on property ownership, marriage, divorce, and child custody. To end rape culture, perpetrators must be held accountable. By prosecuting sexual violence cases, we recognize these acts as crimes and send a strong message of zero-tolerance.

Wherever you see pushback against legal consequences for perpetrators, fight for justice and accountability. One in three women worldwide experience abuse. Violence against women is shockingly common, and we may become witness to non-consensual or violent behaviour. Intervening as an active bystander signal to the perpetrator that their behaviour is unacceptable and may help someone stay safe.

First, assess the situation to determine what kind of help, if any, might be appropriate. You may be able to support the target of sexual harassment by asking how they are or if they would like help, or by documenting the incident, creating distractions to diffuse the situation, or making a short and clear statement directly to the perpetrator such as; *"I'm uncomfortable with what you are doing."* – sourced from United Nations Women Organisation (org).

When *Kurt Gavan Slaven (DOB 07NOV1958; SAPOL/ADF - Navy)* sexually assaulted me under duress in 2001, I was not yet seventeen years of age, and *Kurt Gavan Slaven (DOB 07NOV1958; SAPOL/ADF - Navy)* knew this. Not only was it a record on my driver's licence, a precise relevant detail regarding a traffic offence, but a more important detail is that *Kurt Gavan Slaven (DOB 07NOV1958; SAPOL/ADF - Navy)* asked me my age on the phone before picking me up regarding a discussion of my stolen vehicle. The crime an intentional offence against a minor (South Australian law), more broadly in a federal context it is an offence for a person in a supervisory role to have sexual interactions with a person under their special care who is aged sixteen or seventeen years (Australian government Australian Institute of family studies - aifs.gov.au). This fact is proven and irrefutable, yet SAPOL - nor the AFP charged *Kurt Gavan Slaven (DOB 07NOV1958; SAPOL/ADF - Navy)* for his sex offences over half a decade after SAPOL finally took the statement POLICE vs Kurt Slaven.

Nearly a decade later, the FBI, aware of this heinous crime linked to international organised crime, also visited Australia, yet failed to address the police covering up organised crime sex offending. This is when I lost respect for the FBI and their seemingly bullshit level of integrity – 2023. After years of Epstein investigations that have seen little political repercussions in the United States, I found it disheartening that the FBI's presence here seemed to help elites continue to flout the law more than anything else. Australia's law enforcement was so venal that the FBI's presence only taught the new generation of criminals the FBI's tricks for infiltrating organised crime - the police of Australia were the basis of organised crime at this time. Following in the CIA's footsteps from the early 2000's, where the Gypsy Jokers took hold of the Hells Angels South AUS with SAPOL. One of the briefly touched on relevant events linking USA and Australian law enforcement can be found in article regarding New Zealand Australian felon Benjamin William Ainsworth by Sydney Morning Herald published nineteen years ago: ...'arrested at a Hollywood hostel on Friday by members of the Los Angeles Regional Fugitive Task Force, following an appeal for help from South Australian authorities. He is accused of raping or attempting to rape three young women at knifepoint between July 2000 and October 2003 in Adelaide, according to US Marshals Service Chief Inspector John Clark, who heads the fugitive task force.'

SAPOL and US authorities' cooperation dates back decades, as does the plot of Australian law enforcement, similar to that of US law enforcement, to infiltrate governance through

investigative methods, including organised crime. The competition between our countries has led to Australian authorities, both willingly and unwillingly, committing perjury at the expense of central intelligence, strategic partnerships, and national security. The free world relies on honesty between allies, as well as the ability to maintain privacy regarding sovereign territories. I believed in the FBI after reading James Brien Comey Jr.'s (DOB: 14 DEC 1960) book in 2019. By 2023, after half a decade of leadership by Donald John Trump (born June 14, 1946) and following the appointment of Christopher Asher Wray (born December 17, 1966), I could not say I felt the same. I'm not saying I think Christopher Asher Wray (DOB: 17 Dec 1966) is a bad person. From his appearances on television in court hearings in 2023, he appears to be nervous, which shows humanity and sincerity, primarily with a genuine concern to be a good person. Yet, he is without a doubt invested in protecting the FBI's operations and interests in governing legislation (e.g., Foreign Intelligence Surveillance Act (FISA), an Act of government whistleblowing to be applied at the expense, not the service, of the taxpayer), which can be seen as a conflicting line of leadership. The FBI is required to be non-political in its operations. Regardless of whether you blame the director or not, it is evident that the FBI, like the CIA, has flaws overall. When the help sides with the hindrance, intentionally or unintentionally, the game is somewhat lost to evil. You should never adopt the role of the devil as an investment to proclaim you are an angel.

Kyle Seraphin (DOB1981), a former FBI whistleblower who details how the corrupt FBI is using illegal Foreign Intelligence Surveillance Act (FISA) searches to spy on unwitting Americans and describes the transition of FBI agents to intel analytics. From a real-life perspective, the overuse of analytics technology is precisely what has allowed organised crime and sex trafficking rackets to prosper. The use of invasive tools, which can be easily manipulated in real time, often unfolds over time. Sometimes, the manipulations of analytic tools become evident years after the setups, creating avenues for criminals to prosper for decades. Interviewed on Redacted (USA podcast), Kyle Seraphin (DOB1981) details why so many former FBI agents are now coming forward to blow the whistle on corruption and how the bureau uses dirty tactics to destroy these agents' lives.

The events described throughout this autobiography predominantly focus on a span of approximately thirty years. Twenty years of the lesser-known side of my once very private life. Sexual crimes and innuendo aired out for all to read was the ONLY way I could gain resolution regarding the POLICE vs *Kurt Gavan Slaven* (DOB 07NOV1958; SAPOL/ADF - Navy) statement, as well as end being used and abused by SAPOL and the Australian Police Force without boundaries. Public Disclosure. Justice for the voiceless was gained by tearing my heart out, enduring an obscene cover-up, and sharing my story with the American FBI. The motto, "Fidelity, Bravery, Integrity," succinctly describes the motivating force behind the **men and women** of the FBI.

The exact date of *Kurt Gavan Slaven's* (DOB07NOV1958; SAPOL/ADF - Navy) offence, which was irrefutably covered up, is reflected in various organisational records (PIMS Reports, Vehicle Registration databases, health departments) and major life events that I and others can account for that cannot be altered by maladministration. The offence was committed between February 15, 2001, and April 24, 2001. POLICE VS *Kurt Gavan Slaven* (DOB 07NOV1958; SAPOL/ADF - Navy) statement Original Report Number: 18/D48030; New System Report Number: SAP0010038174, initially reported in 2014 to the Police Ombudsman South AUS – unresolved by 2023 when this publication was a finalized manuscript for print, since revised again in 2025 to include ongoing torts and defamation stemming out of the lack of motivation SAPOL had to resolve their mistakes, choices and illegal operations. Revising taking place from 2019 to 2025 due to the extensive efforts carried out during the writing of this publication

to fill the threat made against my parents while I was a teenager. The threat: to make my father's children 'drug addicts' and myself a 'prostitute'. A prophecy chased by police forces more than organised crime. One can only conclude that the threat was police force-driven through police informants and police members mainly — activity I have personally witnessed, suffered, and nearly lost my life due to during my adult years to date.

The events surrounding this sexual crime are an attempted sexual assault by four boys around my age, cruelty to animals, and stalking. There was also an attempt at sexual assault by a known predator masseuse in Mount Gambier District, Donald A Nunn. I believe this offence was committed at the location of Seven Renfrey Place, Mount Gambier. Tim Argent (DOB 1983, Mount Gambier District, South AUS) picked me up from the east end of Mount Gambier, South AUS in the year 2001. Masseuse Donald A Nunn was the first and only masseuse I have attended. Donald A Nunn asked me to remove all my clothing, and this is how he carried out his massage. During the massage, he inappropriately massaged the top of my thigh very close to my private region. At this point, he asked me if I wanted to return for him to perform an experimental massage in exchange for me cooking him an Indian dinner, to which I declined and felt uncomfortable. The massage session ended shortly after this, and Tim Argent (DOB 1983, Mount Gambier District, South Australia), who had dropped me off at the business, picked me up from the location. I immediately informed Tim Argent (DOB 1983, Mount Gambier District, SA) of what had occurred, and I never returned to this location.

These events occurred around and following *Kurt Gavan Slaven's (DOB 07NOV1958; SAPOL/ADF - Navy) sexual attack on me*, terrorising my life. My pets (two black lop-eared rabbits) were murdered in association with the crime to maintain *Kurt Gavan Slaven's (DOB 07NOV1958; SAPOL/ADF - Navy) threat to me to be silent*, I believe - a form of intimidation and associated with an ongoing chain of crimes. Only the person who killed my rabbits knows the purpose of this vulgar crime of cruelty to animals. The vulgar attacks not ending with the death of my rabbits, the sexual assault attempt by boys in the described property; a chain of other assaults (violent and sexual), torts (harassment and incarceration), and illegal acquisition, abuse of prosecutorial discretion, all driven and/or linked to SAPOL chronicled in this autobiography. The actions of the Adelaide Police Prosecution, in conjunction with the Port Adelaide Police Station, Nuriootpa Police, and Elizabeth, South Australia, in 2024, demonstrate an abuse of prosecutorial discretion that is irrefutable. Prosecutorial discretion refers to the use of a prosecutor's power to decide whether or not to prosecute a case in a manner that is inconsistent with the law or ethical standards, or in a way that unfairly prejudices a defendant. This can include actions such as using the power to harass, retaliate, or pursue a case without sufficient evidence, or when a prosecutor's decisions are based on factors other than the law or the facts of the case. In 2025, the further pursuit of perjury and frivolous charges led Port Pirie Police Station down the same path, engaging in a false arrest and abusing power and process, while also paving another path of clogging the courts with a time-wasting charge at the taxpayer's expense. Commissioner Grant Stevens with no shame in the extent to which he was pushing a cover-up of police sex crimes using an innocent victim and tactics which can only be concluded as efforts to drive the refuge of suicide.

At the scene of the crime committed by *Kurt Gavan Slaven (DOB 07NOV1958; SAPOL/ADF - Navy)* in 2001, a threat made after committing the sex offence on duty against myself - a minor, I was threatened "Don't tell anyone" – *Kurt Gavan Slaven (DOB 07NOV1958; SAPOL/ADF - Navy)* talking about the rape.

The fact that after this vile crime and threat of silence, I was targeted by young, petty gang (COA, Mount Gambier - late 90's early 2000's) associates of *Kurt Gavan Slaven (DOB 07NOV1958; SAPOL/ADF - Navy)* almost immediately after he offended against myself, not

long after my car was stolen gives the impression those boys were aware of myself as a person. Of course, they would have been if any of them were part of the theft of my car, which, with the assistance of Kurt Slaven (SAPOL, Australian Defence Force – Navy), they had gotten away with.

Kurt Slaven (SAPOL & Australian Defence Force - Navy), a police officer who spent his career aligning himself with select criminals - bikers from the Gypsy Jokers, Comancheros/Bandidos, Triads, and Hells Angels, predominantly but not limited to. A police force, trying to dominate the sex industry of South Australia and Australia, allows the rape of minors, solicitation of minors, sex trafficking, and desperately hides the most heinous and hideous crimes. In the years that followed Kurt Slaven's (SAPOL & Australian Defence Force - Navy) sex crimes, SAPOL used me as real-life “rape bait” in a string of unconscious and conscious sex crimes directly associated with SAPOL. Malicious activity collated in the chain of causation, showing offenders and their links to the police force.

For me, the attacks, both psychological and physical, were Military warfare being imposed on a civilian - a little girl. For society, it was an endless undermining of civil rule. Not to mention those ‘crimes against humanity’.

For the most part, my life has been extraordinary, like very good, though my thirties have been thoroughly washed over by a paedophilia cover-up. Which is what this book details, so if you want to read the brighter sides of life, I suggest you refer to my other publications – the ‘ANYTHING BUT ORDINARY Judgement and Perception have NO Value here’ Autobiographical series delves into the good stuff. A series of however many books I would like, the books are full of life truths, candid life experiences, and random facts, as with some of my poetic lines and comedic literature.

Focusing on the Ugly Heros side of life, this True Crime autobiographical research book is full of confronting facts and life events. I endured war style, Nazi type psychological attacks, endless gaslighting from police, freemasons, family members; even friends, boyfriends, and randoms alike. From walks down the street to social media, the agenda was bitter and relentless after years of support and praise. It was weird and made me lose respect for people as they lost their conviction—a bipolar social view of right and wrong. When dissecting my experience, I could only perceive that after years of Mount Gambier residents witnessing the no boundaries extent the government will go to cover up the Truth, that it was easier to find peace in ignorance than to continue to stand for what was right – the stakes too high and the rewards to turn a blind eye tempting I suppose. Finding ignorance more blissful than caring was a standard community census on the taboo subject of sex crimes – dehumanisation, a disgraceful standard of human interaction. A consistent, ignorant, and silent treatment psychological approach, characterized by shunning the truth, was the norm by 2020, two years after I began writing this book. Even the media pleaded ignorance and remained silent. Despite having much evidence of the venal state of police and government, plus a Public Information Disclosure - The Story Behind the Brand BARBWIRE NOOSE (my Human Rights brand), published across the globe by 2023.

From a psychological perspective – the approach of government and SAPOL/STARForces in a character assassination to cover up crimes in government consisted of ambiguity based on falsified facts (aspersions and perjury), deception (operations with the agenda to confuse and conflate facts), psychological attacks, gaslighting, denial and feigned psychosis induced by psychological warfare activity perpetrated under police operations including AFP forces. Global studies show that government victims, whistleblowers, etc, are often the target of claims of mental instability (discussed in further reading) and are gaslighted.

"What form does power take in situations of retaliation against whistleblowers? In this article, we move away from dominant perspectives that see power as a resource. In place, we propose

a theory of normative power and violence in whistleblower retaliation, drawing on an in-depth empirical study. This enables a deeper understanding of power as it circulates in complex processes of whistleblowing. We offer the following contributions. First, supported by empirical findings we propose a novel theoretical framing of whistleblower retaliation and the role of mental health, which draws upon poststructuralist psychoanalytic thinking. Specifically, we highlight how intra- and inter-psychic affective and ambivalent attachments to organizations influence the use of normative violence in cases of whistleblower retaliation. The second contribution is empirical and builds upon the existing literature on whistleblower retaliation by highlighting how organizations position whistleblower subjects as mentally unstable and unreliable individuals, to undermine their claims. We conclude by highlighting the implications of normative power for the outcomes of whistleblower struggles." - *Kenny, K., Fotaki, M. & Sriver, S. J Bus Ethics (2018).*

As summarized in this study on mental health related to whistleblowing. Mental Health instability is the token go-to accusation for claims against authorities, and the extent to which the Police were trying to grasp at regarding myself. Endless defamatory pursuits that are utterly beyond my realm of understanding as a victim of serious criminal conduct by police. The defamation generated at this time was severely damaging and had me targeted by many opportunists, as I call them, 'so-called' friends or fence sitters. Examples of this defamation can be sourced from publicans, persons friends with police or police officers involved – including the Department of Corrections employees naming specifically last name Maude employee of prisons Soth Australia and his defence force trade (NSW based industry trade) linked father (Matthew Maude ABN:40 959 798 278) who engaged in defamatory discussions and encouraged life effecting misogynist actions in 2025 – after many correlating and relevant facts had been publicly disclosed and publish via Austin Macauley Publication 'The Story Behind the Brand – BARBWIRE NOOSE' authored by founder of the clothing brand; me. People who would do anything for a dodgy leg up in life, fifteen seconds of fame; people even committing sexual crimes, all things, for petty benefits. Despicable behaviour by Anyone.

When the police force failed to convince enough of the population of my mental instability by 2023, SAPOL engaged incarceration torts (2024) initiated by VICPOL in 2022. Yes, you are reading facts, the facts show SAPOL incarcerated myself based on police perjury involving the very predator that raped me at sixteen years old *Kurt Gavan Slaven (DOB 07NOV1958; SAPOL/ADF - Navy)*. Clear abuse of prosecutorial discretion by countless SAPOL officers under the direction of the Commissioner of SAPOL, Grant Stevens. Read Autobiography: Political Prisoner #192703 *The Price of Unlawful Enforcement* (ISBN: \*\*\*-\*\*\*\*\*-\*\*\*-\*, paperback, hardcopy, e-book & 978-064578-609-5; E-Pub PDF) for the details and documents regarding this tort. Or flick to the Conclusion Chapter of this book for the basics of the jail experience. Punitive actions by police coupled with procedural irregularities, I suffered extensively during 2024, traumatised by this extraordinary, outrageous, illegal activity of the police 'Boys Club'. After spending a decade on their cover-up, the next approach reflected the tired attitude I experienced in my hometown at the height of the police force cover-up announced as successful by a women's safety employee - Stephanie Baker (2020) – silent treatment and ignorance, the tools of oppression. The oligarchy ('oliga:ki; noun - a small group of people having control of a country or organization) is often a last resort, characterized by ignorance and silencing the media.

My family has infamously tried the silent approach for years, which, as you can see, was very unsuccessful as an oppression tactic. I have had a much more successful, productive life, not living in the shadows of their lies, denial, greed, and ignorance. Ignorance, also known as the silent treatment, is strikingly similar to gaslighting, as both tactics flourish in exerting power and control. Some therapists call the silent treatment a form of gaslighting, used to cause

personal uncertainty and a sense of doubt when considering goals, self-views, and worldviews. I was certainly putting my views and truth to the world confidently, and I have no doubt this is what police ignorance was supposed to achieve in the latter years of public disclosure, in a cover-up. All failed miserably. The determination I saw to ignore the truth only inspired me to make the truth too big to ignore.

I have endured and survived some of the most extreme forms of private and public sector gaslighting on record. Furthermore, some of the technology and tactics I have witnessed are the most extreme gaslighting and psychological warfare the mind can endure. There were relentless and endless home invasions, starting with my two rabbits being murdered in the first rental property I resided in 2001, the gaslighting events occurring not long after *Kurt Gavan Slaven's* (DOB 07NOV1958; SAPOL/ADF - Navy) sexual offence. The death of my pets following a failed sexual assault attempt by four boys, an attack on my person associated with sex offender *Kurt Gavan Slaven* (DOB 07NOV1958; SAPOL/ADF - Navy). These boys were not known to me in 2001, yet they were known to SAPOL and the Mount Gambier CIB. Known to SAPOL sex offender Kurt Slaven and said to be responsible for the theft of my VH Holden Commodore (UFK 895), which led to Kurt Slaven's (SAPOL & Australian Defence Force - Navy) predatory sex offence against me, a minor at the time. I have no doubt Kurt Slaven (SAPOL & Australian Defence Force - Navy), writing this Autobiography with many facts unveiled and irrefutable, that the cover-up of the vehicle theft was directly correlated with the attempted sexual assault, the start of the chain of causation. The boys said to be part of a youth gang called COA (COA = Constantly on Attack) associated with the Gypsy Jokers, a Nazi aligned biker gang as well as American biker gang the Bandidos, Hells Angels counterparts Red Devils and Australian biker club the Comancheros. Links created and assisted by corrupt SAPOL police officers and operations. The COA youth gang was created by SAPOL officers recruiting seedy and criminal family members as human resources - informants. An expanding informant gang of relatives and friends directly linked to the police force, associating and recruiting young impressionable boys at this time in Mount Gambier, extending to Adelaide, the Capital City of South Australia. The COA was predominantly recruiting low-socioeconomic students predominantly from Grant High School and desperate to fit in Mount Gambier High School students as well as other schools in the regional area of South Australia at this time. This group of boys latching onto like-minded, impressionable young persons. Twenty years after this human resource sex offender gang, the COA, was developed these boys had spread across the Nation – throughout Australia, most of them drug addict, sex industry pimp wannabes recruited as human resources, spreading STD's (knowingly without disclosure to partners), aligning with the various gangs in Australia. This is how the bikers in Australia gained further power and control within Australia using their known avenues of extortion of venal married men, police, and politicians - anyone who wanted to hide crimes or infidelity. The definition of a biker in Australia was basically a human resource willing to rape sex industry workers - anyone who spoke out against police and corruption in government alike after seedy police and seedy informants joined gangs and spread the word on how to be a successful sex offender. 'Deny, Deny, Deny' is a key to offending, which is often one person's word against another. This is where polygraph tests serve a real purpose in court. It is easy to ask the question "have you sexually engaged with persons underaged?", etc – the offender doesn't even need the victim mentioned to confirm their crime. Something police are unwilling to do, as sex offending is a systemic problem.

Operations recruiting known felons with more to hide than a drug dealer dobbing to police so they can continue to target children, women, and the vulnerable is disgusting. And disgustingly real. After decades of signing sex offender felons and related heavy drug users as informants and human resources, police co-operation with their criminal counterparts was not winning the

war on drugs yet was winning the bikers' plight for power against law enforcement. The venal police force was so far gone when Australia entered the era of National Integrity backboneless against organised crime aligned sexual offences. Especially crimes against sex workers, one of the oldest professions in the world, whether we like it or not.

It can be argued that policing operations have difficulties, especially surrounding organised crime. Yet, it can't be denied that police forces' heavy involvement in crime as opposed to society's safety is the dominating factor of this problem. Police be Police, Gangsters be gangsters – I say this a lot.

The twenty-four of February 2025, Natalie O'Brien journalist for 'The Nightly' print media published article reading: ***'AFP bungle potentially leaves cops who infiltrated dangerous crime networks exposed to vengeful mobsters; A group of undercover police officers who infiltrated some of the world's most dangerous crime networks only to be forced into hiding when their cover was potentially blown, have thrown themselves on the mercy of the Attorney General asking for protection.***

*The agents are pleading for help saying their former employers, the Australian Federal Police, have bungled their case and failed to ensure their safety from mobsters who think nothing of killing suspected informers let alone undercover cops.*

*In a rare glimpse inside the world of undercover police operations, the former cops say they and their families were exposed after discovering their assumed identities may have been compromised and then being left with no "exit strategy" or story to give the crooks for suddenly vanishing from their entrenched positions.*

*"Deep infiltration by Australian undercovers on major organised crime targets in Australia should never have been considered in the first place without proper exit strategies, ensuring we were relocated overseas for an extended period of time," one agent said.*

*"It was a half-baked plan to deploy us with no real consideration of our real lives when it comes to the end," they said.*

*The Australian Federal Police Association (AFPA), acting for the agents, has written to the Federal Attorney-General, Mark Dreyfus, and the AFP Commissioner Reece Kershaw for help.*

*AFPA's President Alex Caruana has requested the undercover agents get the proper safety measures they deserve.*

*"Their service in high-risk and challenging conditions, along with their unwavering commitment to protecting our country and communities warrants this attention and intervention," Mr Caruana wrote.*

*The unprecedented situation has also sparked a number of professional standards investigations into four senior AFP police officers accused of misconduct in the way they handled a risk and threat assessment for the agents which found there was a "expected" or certain threat but then ordering a subsequent "body of works" assessment which downgraded the threat to just "possible".*

*In a letter to the AFP Commissioner, the AFPA stated said they had "been advised by a senior AFP member involved in the 'body of works' of the misconduct, malpractice and poor work standards that took place during its production."*

*The Attorney-General has previously been asked to investigate the treatment of undercover police operatives by the Parliamentary Joint Committee on Law Enforcement, because the committee did not have the power to investigate individual complaints or to review sensitive material. The undercover agents have taken action against the AFP under the Scheme for Compensation for Detriment caused by Defective Administration, to cover international relocation costs for them and their families, loss of wages, superannuation, and security costs.*

*The agents who had infiltrated more than one crime group at the highest levels — multiple times — for years in various locations around the country now say Australia is no longer safe for them.*

*The agents argue the only thing the AFP has done is install security systems with a panic button in their homes, which does nothing to protect them if they have an encounter outside their homes or while out with their families.*

*Greens Justice spokesman, Senator David Shoebridge, said these agents had put their lives on the line and when they desperately need help have been abandoned.*

*“They are asking for new identities and to keep them their families safe and that involves a bit more than providing a panic button,” Senator Shoebridge said.*

*“What they are asking for will disrupt their lives but experienced officers only ask for something like this if it is really needed.”*

*Senator David Van who has drawn the case to the attention of Attorney-General Mark Dreyfus said “I believe all good-hearted Australians would be outraged at the treatment of these agents by the AFP, I certainly am.”*

*“The lack of care and action by the AFP can only be explained by an unwillingness to provide the funds to protect them - it’s fiscally driven,” Senator Van said.*

*“The security of these members has not been taken seriously and this is reason enough to suspend the undercover program.*

*“It is arguable that members should think long and hard before going undercover, potentially putting themselves in harm’s way.*

*“If the AFP is too heartless to remedy this situation, the Attorney-General must act urgently. If Minister Dreyfus fails to act then if any harm befalls these brave police the responsibility lands squarely on his shoulders.”*

*The agents say “above everything ...what we want is accountability and for the misconduct that has occurred to be uncovered and our safety addressed by the AG. Ultimately the AFP are not a mature enough organisation to run such a high risk endeavour.”*

*A classified review of the AFP undercover program in late 2023 by retired AFP assistant commissioner Frank Prendergast showed it had been compromised for years by systemic failures, outdated technology and inadequate security.*

*The AFP have since said the undercover program has since been overhauled.*

*An AFP spokeswoman said they assess threats and risks to current and former members of the undercover program and apply appropriate security mitigations.*

*“At present, the AFP have not identified any direct threat to these former members,” the spokeswoman said.*

*“Over the 22 years of the program, we have never had an undercover operative physically harmed through the course of their duties.”*

*The Attorney-General has been contacted for comment.*

**This article reflects many of the concerns and content raised in this Autobiography. The Price of Unlawful Enforcement is heavy for both sides of the fence, police and the public both suffering from governing criminal negligence.**

Australian politicians and the broadly compromised police force were so heavily involved and out of control when organised crime began to collude against the association laws in 2012. By 2023, illegal operations and activities exposed in the media on television shows like ABC 4corners and in television series narratives like *Underbelly* in Australia provided evidence of claims I had publicly disclosed against the police force for five years in writing. By 2025, it is irrefutable that the worst move the police and governance made was to implement strategic narcissism legislation - the association laws. Laws that in 2012 led to bikers across Australia meeting in Australia's tourist hub, Queensland (QLD). The brotherhoods binding together with one common goal, suing the government over this legislation, not fit for purpose, and in violation of Constitutional rights and Human Rights (Universal Declaration of Human Rights charter). It only took a short four years after 'the world's toughest anti-bikie laws' were introduced, before it was evident and time and time again proven that these breaches of Universal Human Rights, the Constitution, and Privacy laws were unlawful when applied. The association Laws allowing Police Brutality and gang-like violence, including sex crimes against minors; rape and murder driven activities, to escalate. Abuse of prosecutorial discretion violates Constitutional law. Engaged and encouraged by the Australian Police Force and Tactical Teams from Top to Bottom, state and nationally. These unlawful attacks on persons and premises are the sole reason behind the bikers in Australia aligning.

It was in May 2008 when the Labor Government of South Australia passed what Premier Mike Rann (DOB5JAN1953) proclaimed as 'the world's toughest anti-bikie laws' (Rann 2008), with the introduction of the Serious and Organised Crime (Control) Act 2008, which came into effect on 4th September 2008. Mike Rann (DOB5JAN1953) is a paedophile and also the Premier at the time of my first experience reporting against government sector negligence. Reporting on behalf of disabled persons under Government care and Public Trustee funding at times, over the years 2003 – 2007.

It was also in 2008 when my house was invaded by police and the government under these laws. An innocent little girl sexually assaulted by a paedophile police officer as a minor in 2001, suddenly at twenty-four years of age, to become a targeted individual due to reporting against the Mike Rann (DOB5JAN1953) government. Two paedophiles working together targeting my person is not a coincidence. A whistleblower seen as a threat to the South Australian Labor government regarding my knowledge of Disability sector criminal negligence and more broadly negligence regarding the Mount Gambier, South Australia community, being one of the first people targeted by the unconstitutional association laws, is also not a coincidence. These laws have always been corruptly used; they assume criminality without judicial proceedings and have been criminally implemented for political gain from the start.

Having my Privacy stripped from me in cover-up upon cover-up, my bedroom door filmed nearly every day I owned my house on Penola Road in Mount Gambier until 2014 at the least. These laws, abused unlawfully since their implementation and for over fifteen years, have proven to not only escalate the violence and crime as Arthur Veno predicted but also compromise the nation's National Security.

Doctor Arthur Veno; expert Adjunct Professor of Criminology (Monash University). Professor Arthur Veno was born in the US (1945) and lived in Australia since 1974, passing away in 2019 (R.I.P). Quoting the criminology expert "It's a desperate mistake and one that makes the police seem as if they're doing something, but in every other country where it's been tried it has had no success."

Australia's Crimes Legislation Amendments (Serious and Organised Crime) Act 2010 was some of the worst breaches of Human Rights globally amongst developed societies. Allowing for large-scale corruption and global racketeering from our Country.

Premier Mike Rann (DOB 5 JAN 1953) cited the following as highlights of the Act:

- gang members who engage in acts of violence that threaten and intimidate the public will be guilty of serious offences and will find it harder to get bail;
- police will be able to prohibit members of a bikie gang from attending a place, event or area where this would pose a serious threat to the public;
- the old law of consorting will be replaced with a new law of criminal association that prohibits telephone calls as well as meetings in the flesh;
- stalking a person with the intention of intimidating a victim, witness, court official, police officer or public servant will become a serious offence;
- it will be easier for police to secure orders to dismantle fortifications protecting gang clubrooms; and
- in addition, the legislation created new offences of violent disorder (maximum penalty of 2 years jail); riot (7 years, 10 years where aggravated); affray (3 years, 5 years where aggravated) and stalking of public officials by OMCG members (7 years; Rann 2008).

By 2023, Arthur Veno's words were not only irrefutable but they were also evident. Australian Police Forces have been seeking the assistance of the FBI since at least 2021 regarding biker activity. Funnily enough, very little changed over the years regarding sexual exploitation, especially in the district of Mount Gambier, South Australia, harbouring Australia's ICE cooks and serious sex offenders. From 2021 to 2024, Australian newspapers endlessly reported on organised crime violence and its escalation, with much gangland war violence seen in the media, including biker presidents murdered and wars between gangs escalating.

All of Australia's organised crime policing units were compromised, not just from the top down, but also politically. Intelligence regarding organised crime was corrupt from the detective units involved in paedophilia right through to police commissioners, the police ministry, and even the courts in Australia. Our twenty-eight VIP (very important persons!??) paedophiles are just the tip of the Iceberg of Australia's continent of Epstein's benefiting from their alliances with organised crime. At the same time, this unconstitutional, fallacious law targets innocent friends and bikers' children. The association laws do not serve the people; they serve power and overstep fundamental Human Rights.

The association fallacy: a formal fallacy that asserts that properties of one thing must also be properties of another thing if both things belong to the same group. For example, a fallacious arguer may claim that "bears are animals, and bears are dangerous; therefore, your dog, which is also an animal, must be dangerous. It is proposed that when it is an attempt to win favour by exploiting the audience's preexisting spite or disdain for something else, it is called 'guilt' by association or an appeal to spite (Latin: *argumentum ad odium*). 'Guilt by association' is like *ad hominem* arguments, which attack the speaker rather than addressing the claims, but in this case, the ill feeling is not created by the argument; the spite/disdain already exists (for bikers, organised crime, prostitution).

This Autobiography captures my undoubtedly and undeniably abused side of life and how strategic narcissism only enables organised crime. The book proves irrefutably that SAPOL (police forces, including NSWPOL, VICPOL, NTPOL, and AFP – not limited to) has

committed criminal negligence concerning the misuse and abuse of my person. The venal state of Australian governance and policing is exposed. A necessary public disclosure that shines a light on the integral necessity of Human Rights. I legally prove the detriment of cover ups (Perjury); results of floundering duty of care (negligence) in governance and show the association laws irrefutably are not fit for purpose, being used by police to cover up governance crimes applying the laws without legal address of breaches to Constitutional Rights (section 51(xxxi) acquisition of property on just terms, section 80 trial by jury, section 116 freedom of religion, section 117 state of residency) and Human Rights. Not fit for purpose legislation is abused to obtain feigned plausible deniability and Constructive ambiguity. Constructive ambiguity is a term generally credited to Henry Kissinger, said to be the foremost exponent of the negotiating tactic it designates. It refers to the deliberate use of ambiguous language on a sensitive issue in order to advance some political purpose.

Simply put, the Association Laws of Australia are loosely framed legislation intentionally allowing tyranny. Legislated strategic narcissism, allowing constructive ambiguity and plausible deniability to be utilized to cover up governance sex crimes (including crimes against the disabled and minors). Deniability and ambiguity enable political advancement through the application of unconstitutional laws.

Personally, the most honest accounts of Strategic narcissism use and abuse I have researched are presented by Lt. Gen. H.R. McMaster (DOB 24 JUL 1962), former National Security Advisor during Donald J. Trump's (DOB 14 JUN 1946) administration, in a bold assessment of the most critical foreign policy and national security challenges of our age. For more information on this subject, I suggest searching for his work; he's a class act with an outstanding career and, more importantly, an invaluable scope of knowledge.

After witnessing strategic narcissism to no end, the act/practice of illegal government spy tactics, the use of spies to benefit governments (local and international) activity to discover the military and political secrets of other parties with opposing underlying governance agendas (e.g. Democratic; Autocratic; Republic; Commonwealth) I know too well strategic narcissism is of no long-term benefit to either party engaging the strategy. Institutional and systematic compromises are playing out with both sides of the government using the police force to spy on each other's sexual misconduct for political gain.

**Political** means relating to the way power is achieved and used in a country or society.

If a person or place (party) **gain** something, such as an ability or quality, they gradually get more of it.

"Political gain has been allowed over time to become more important than making decisions in the public interest. That is in large part due to the growth of ministerial advisers," - *Mr Redlich, a former head of the state's Independent Broad-based Anti-Corruption Commission, told The Australian Financial Review (2023).*

Both governments could be said to be aligned with all gangs in Australia, as the motorcycle clubs were against their own best interests cooperating with each other since 2012, with their plot against the association laws. Liberal more heavily aligned with the Gypsy Jokers via Antony "Tony" Pasin (DOB1OCT1977), the political party member for Barker (Mount Gambier and districts) Antony "Tony" Pasin (DOB1OCT1977) an old Mount Gambier lawyer with a cocaine/methamphetamine habit fed by the joker's biker gang entered politics in 2013 and was re-elected in 2019 – at the height of my whistleblowing Labor criminal negligence. Criminal politicians, rorts, and paedophilia are corrupting politics across Australia. William

Richard Shorten (DOB12MAY1967), leader of the opposition and leader of the Australian Labor Party from 2013 to 2019, called out on a public free-to-view television show, 'Parliament Time' aired on ABC TV, regarding his affiliation with the Hells Angels. Mark Butler (DOB8JUL1970), Federal Labor Government (Health and Aged Care Ministry) Minister, who was in a leadership role with the Liquor, Hospitality and Miscellaneous Union (LHMU). Unions of Australia are said to be involved in exploitation, extortion, bullying, and even physical assaults. The LHMU turned United Voice, an Australian trade union, from 1992 to 2019. LHMU merged with the National Union of Workers to form the United Workers Union; United Voice is part of the Labor Left faction of the Australian Labor Party. Ministers have been using the boys' clubs like unions to harvest political votes for decades and reward persons who will target individuals on their behalf.

Reading this true crime, real-life analysis/report, you will realise, as did I, that the bikers' association is a constitutional right and the undue focus on organised crime is a deflection from those who control and conspire to the lowest crimes within society (sex crimes, paedophilia, etc).

Accurate accounts of Australia's only two elected serving government's (Labor – red, and Liberal - blue) being heavily corrupted, with no real accountability in their out-of-control malfeasance, tyrannical/hyper legislation implementation, human rights violations, crimes including military crimes, and overall lack of integrity - which could be concluded as a form of espionage; a severe internal erosion of National Integrity compromising Australia's National Security while public accountability is eluded.

*Monsters don't hide under your bed; they hide in law enforcement.*

Make no mistake, these times reveal that the percentage of sex offenders in society can be equally matched in percentage to those who serve in law/military forces.

The endless illegal cover-ups, legally publicly disclosed in this book, are an example of the venal depths of government. The censorship attempts and desperation of all involved to dilute the truth, unveiled amidst the most corrupt climate in Australia's governance history, as the country headed into nationally legislated Integrity.

An individual is not subject to any civil, criminal or administrative liability for making a public interest disclosure. It is an offence to take a reprisal, or to threaten to take a reprisal, against a person because of a public interest disclosure (including a proposed or a suspected public interest disclosure). The Federal Court or Federal Circuit Court may make orders for civil remedies (including compensation, injunctions, and reinstatement of employment) if a reprisal is taken against a person because of a public interest disclosure (including a proposed or a suspected public interest disclosure).

It is an offence to disclose the identity of an individual who makes a public interest disclosure.
